Regular Monthly Meeting
September 11, 2017

The September 11, 2017 regular monthly meeting of the Covington Township Board of Supervisors was held in the Covington Township Municipal Building at 114 East Hill Road, Covington PA. Chairman Lisowski called the meeting to order at 7:00PM. Present along with the Chairman was Supervisor Richard Powlison, Supervisor Frank Yungwirth and Assistant Secretary Donna Casselberry.
